- 25 1. Plaintiffs Mohit Randhawa and Shannon Callnet Pvt Ltd.
 (“Plaintiffs”) filed a Second Amended Complaint on January 6, 2010,
 following orders by the Court on November 3, 2009 (Docket No. 27),

1 on December 2, 2009 (Docket No. 36), and on December 21, 2009

3 2. In the Second Amended Complaint, Plaintiffs have added a new
4 Defendant, SKYLUX TELELINK PVT LTD. (“STPL”).

5 3. STPL is represented in this action by Gregg A. Rapoport, who is
6 counsel of record for Defendants SKYLUX INC. (“Skylux”) and
7 MUJEEB PUZHAKKARAILLATH (“Puzhakarailath”), as well as
8 co-counsel for Defendant INTERACTIVE INTELLIGENCE, INC.

9 4. Mr. Rapoport has agreed to accept service and acknowledge receipt of
10 the Summons and Second Amended Complaint on behalf of STPL,
11 when provided by Plaintiffs.

12 5. The current deadline for Defendants Skylux and Puzhakarailath to
13 respond to the Second Amended Complaint is January 20, 2010 (14
14 days after its filing, pursuant to Rule 15(a), Fed. R. Civ. P.

15 6. Defendants’ counsel have requested a seven (7) day extension of time
16 within which to file responses to the Second Amended Complaint,
17 and anticipate that responses by all Defendants will be filed at that
18 time. This request is made in part due to Mr. Rapoport’s required
19 jury service during the week of January 18th.

20 7. Plaintiffs’ counsel has agreed to this request.
