**STIPULATION TO EXTEND DATE FOR RESPONSIVE PLEADING TO
 COUNTERCLAIMS; ORDER THEREON**

1 This stipulation is made by and between Plaintiff BLX Capital, LLC
2 (“BLX”) and defendants Dara Petroleum, Inc. (“Dara”), Sarbjit S. Kang (“Kang”),
3 and Narges Eghtesadi (“Eghtesadi” and collectively with Dara and Kang,
4 “Defendants”), by and through their respective counsel of record, with respect to
5 the following facts:

- 6 1. On October 30, 2009, defendants Dara and Kang filed an Answer to
7 Complaint and Counterclaim against BLX (the “Dara/Kang
8 Counterclaim”).
- 9 2. On November 24, 2009, defendant Eghtesadi filed an Answer to
10 Complaint and Counterclaim against BLX (the “Eghtesadi
11 Counterclaim”).
- 12 3. Defendants have filed a Notice of Unavailability of Counsel effective
13 from December 14, 2009 to January 5, 2010.
- 14 4. BLX requests additional time to file a responsive pleading.
- 15 5. Defendants agree to the extension of time to file a responsive pleading
16 to the Dara/Kang Counterclaim and the Eghtesadi Counterclaim.

17 NOW, THEREFORE, IT IS STIPULATED as follows:

- 18 1. BLX shall have until January 7, 2010 to file a responsive pleading to both
19 the Dara/Kang Counterclaim and the Eghtesadi Counterclaim.
