ORDER FOR PAYMENT

OF INMATE FILING FEE

To: The Sheriff of Sacramento County, Attention: Inmate Trust Account, 651 I Street,
Sacramento, California 95814¹:

Plaintiff, a county jail inmate proceeding pro se and in forma pauperis, is obligated to pay the statutory filing fee of \$350.00 for this action. Plaintiff is assessed an initial partial filing fee of 20 percent of the greater of: (a) the average monthly deposits to plaintiff's trust account; or (b) the average monthly balance in plaintiff's account for the 6-month period immediately preceding the filing of this action. 28 U.S.C. § 1915(b)(1). Upon payment of that initial partial filing fee, plaintiff will be obligated to make monthly payments in the amount of twenty percent of the preceding month's income credited to plaintiff's trust account. The Sheriff

¹ If plaintiff is no longer detained in the Sacramento County Jail, the Sheriff or a designee shall so inform the Clerk of Court, including, if possible, plaintiff's forwarding address.

1 of Sacramento County is required to send to the Clerk of the Court the initial partial filing fee
2 and thereafter payments from plaintiff's prison trust account each time the amount in the account
3 exceeds \$10.00, until the statutory filing fee of \$350.00 is paid in full. 28 U.S.C. § 1915(b)(2).

4 Good cause appearing therefore, IT IS HEREBY ORDERED that:

5 1. The Sheriff of Sacramento County or a designee shall collect from plaintiff's
6 trust account an initial partial filing fee in accordance with the provisions of 28 U.S.C. §
7 1915(b)(1) as set forth in this order and shall forward the amount to the Clerk of the Court. The
8 payment shall be clearly identified by the name and number assigned to this action.

9 2. Thereafter, the Sheriff of Sacramento County or a designee shall collect from
10 plaintiff's trust account monthly payments from the account in an amount equal to twenty percent
11 (20%) of the preceding month's income credited to the prisoner's trust account and forward
12 payments to the Clerk of the Court each time the amount in the account exceeds \$10.00 in
13 accordance with 28 U.S.C. § 1915(b)(2), until the \$350.00 filing fee for this action has been paid
14 in full. The payments shall be clearly identified by the name and number assigned to this action.

15 3. The Clerk of the Court is directed to serve a copy of this order and a copy of
16 plaintiff's signed in forma pauperis affidavit on the Sheriff of Sacramento County, Attention:
17 Inmate Trust Account, 651 I Street, Sacramento, California 95814.

18 4. The Clerk of the Court is directed to serve a copy of this order on the Financial
19 Department of the court.
