1 **STIPULATION**

2 This Stipulation is entered into by Plaintiffs FRANK WILLIAMS and CINDY WILLIAMS
3 (collectively, "Plaintiffs") and Defendants BANK OF AMERICA CORPORATION ("BoA"),
4 COUNTRYWIDE HOME LOANS, INC. d/b/a AMERICA'S WHOLESALE LENDER ("CHL")
