18 The motion of Defendants CHICAGO TITLE COMPANY, KAREN BRENNAN, and
 19 GREG FARR (hereinafter collectively "Defendants") for Summary Judgment came on regularly for
 20 hearing before this Court on October 19, 2011. Andrea Rosa, Esq., appeared as attorney for Plaintiff
 21 Elena Crawford and Christopher Wohl, Esq., appeared as attorney for Defendants.

22 After considering the moving and opposition papers, arguments of counsel and all other
 23 matters presented to the Court, IT IS HEREBY ORDERED THAT DEFEDANTS' MOTION FOR
 24 SUMMARY JUDGMENT IS PARTIALLY GRANTED AS FOLLOWS:

- 25 1. Chicago Title Company's request for Summary Adjudication and dismissal of Count I
 26 (Retaliation under 42 USC Section 1981) is DENIED;

- 1 2. Chicago Title Company's request for Summary Adjudication and dismissal of Count II
2 (Race Discrimination under 42 USC Section 1981) is DENIED;
- 3 3. Chicago Title Company's request for Summary Adjudication and dismissal of Count III
4 (Wrongful Termination in Violation of Public Policy) is DENIED;
- 5 4. Chicago Title Company's request for Summary Adjudication and dismissal of Count IV
6 (Breach of Employment Contract) is DENIED;
- 7 5. Chicago Title Company's request for Summary Adjudication and dismissal of Count V
8 (Breach of the Implied Covenant of Good Faith and Fair Dealing) is GRANTED;
- 9 6. Defendants' request for Summary Adjudication and dismissal of Count VI (Negligent
10 Infliction of Emotional Distress) is GRANTED;
- 11 7. Defendants' request for Summary Adjudication and dismissal of Count VII (False Light)
12 is GRANTED;
- 13 8. Defendants' request for Summary Adjudication and dismissal of Count VIII (Negligent
14 Interference with Prospective Economic Relations) is GRANTED;
- 15 9. Chicago Title Company's request for Summary Adjudication and dismissal of Count IX
16 (Failure to pay Overtime Wages in Violation of Labor Code and IWC Wage Orders) is
17 GRANTED;
- 18 10. Chicago Title Company's request for Summary Adjudication and dismissal of Count X
19 (Failure to pay Minimum Wage in Violation of Labor Code section 1197) is GRANTED;
- 20 11. Chicago Title Company's request for Summary Adjudication and dismissal of Count XI
21 (Waiting Time Penalties under Labor Code sections 201 and 202) is GRANTED;
- 22 12. Chicago Title Company's request for Summary Adjudication and dismissal of Count XII
23 (Failure to pay Wages in Violation of Business and Professions Code section 17200) is
24 GRANTED;
