1 Having read the foregoing Stipulation and good cause appearing therefor, the  
2 Court GRANTS the Stipulation to continue Plaintiff's Motion for Collective Action  
3 Certification and ORDERS the following:

4 1. The hearing date on Plaintiff's Motion for Collective Action  
5 Certification is continued for a period of seven weeks from June 21, 2010, to  
6 August 9, 2010;


7 2. The deadline for Defendants to file and serve an Opposition to  
8 Plaintiff's Motion for Collective Action Certification is continued from June 7,  
9 2010, to July 12, 2010. The deadline for Plaintiff to file a Reply in support of her  
10 Motion for Collective Action Certification is continued from June 14, 2010, to July  
11 26, 2010;

12 3. The running of the statute of limitations as to the FLSA cause of action  
13 is hereby tolled for a period of seven weeks (for a total of eleven weeks) for each  
14 putative California collective action member, if any, who elects to opt into this  
15 action.

16 4. The Further Status Conference is continued for a period of seven  
17 weeks from June 21, 2010 until August 9, 2010 at 1:30 p.m.
