11 (g) Documents produced by Bass Pro that are marked "Highly Confidential -
12 Attorneys' Eyes Only" may only be viewed by Best Buy's outside counsel and not by Best
13 Buy's in-house counsel.

14 3. Bass Pro will redact any economic/financial terms from the documents
15 produced.


