5 statement would be due June 14, 2010. Plaintiff filed a
6 Stipulation and Proposed Order on May 21, 2010, granting
7 Defendants an extension of time to respond to the complaint
8 until June 1, 2010. Plaintiff had granted Defendants a
9 second extension of time until July 1, 2010. A third
10 extension of time for Defendants to respond until August 2,
11 2010 has been filed. A continuance of the date for filing
12 a joint status conference statement from July 12, 2010 to
13 August 16, 2010 would give the Defendants time to file a
14 response to Plaintiff's complaint.


