

12 Counter-claimants were required to respond to an Order filed
13 September 29, 2011 by filing a document showing good cause for their
14 failure to serve cross-defendant Autism Reform California within the
15 120-day period prescribed in Federal Rule of Civil Procedure 4(m). (ECF
16 No. 143, 2:15-25.) This filing was due no later than 4:00 p.m. on
17 October 7, 2011. Id. The September 29, 2011 Order warned cross-
18 claimants that failure to make the required showing by the deadline may
19 result in this cross-defendant being dismissed from this action.

20 Cross-complainants failed to respond to the September 29, 2011
21 Order. Therefore, cross-defendant Autism Reform California is dismissed
22 from this action without prejudice.
