ORDER OF TRANSFER 8 VS. 9 KEN CLARK, Warden, (Docket No. 2) 10 Respondent. 11 12 Petitioner, a prisoner of the State of California, currently incarcerated in 13 Corcoran, California, has filed a petition for a writ of habeas corpus in this Court 14 challenging the constitutionality of his state conviction from Sacramento County. 15 Petitioner has also filed an application to proceed *in forma pauperis* (docket no. 2). 16 Venue is proper in a habeas action in either the district of conviction or the district 17 of confinement, see id § 2241(d). Federal courts in California traditionally have chosen 18 to hear petitions challenging a conviction or sentence in the district of conviction. See 19 Dannenberg v. Ingle, 831 F. Supp. 767, 767 (N.D. Cal. 1993); Laue v. Nelson, 279 F. 20 Supp. 265, 266 (N.D. Cal. 1968). Therefore, the Court ORDERS that pursuant to 28 21 USC § 1404(a) and Habeas LR 2254-3(b), and in the interest of justice, the Clerk of the 22 Court shall TRANSFER this matter to the United States District Court for the Eastern 23 District of California forthwith.
