ORDER FOR SANCTIONS AND
FURTHER ORDER TO SHOW CAUSE

19 On June 4, 2010, plaintiff's counsel, Mr. Piotr Gabriel
20 Reysner, was ordered to show cause why he should not be
21 sanctioned in the amount of \$150.00 for failing to appear at the
22 hearing on Plaintiff's Motion for Preliminary Injunction. The
23 court ordered counsel to file his response to the Order to Show
24 Cause on or before June 25, 2010. As of today's date, a response
25 has not been filed.

26 Plaintiff has also failed to file and serve an opposition
27 brief or notice of non-opposition to defendant's Motion to
28 Dismiss (Docket # 13) in compliance with Local Rule 230(c).

1 Therefore, the court makes the following orders:

2 1. Plaintiff's counsel, Mr. Piotr Gabriel Reysner, is
3 ordered to pay sanctions in the amount of **\$150.00** for his failure
4 to file a response to the Order to Show Cause filed on June 4,
5 2010. Payment should be in the form of a check made payable to
6 the Clerk of the Court. The sum is to be paid personally by
7 plaintiff's counsel **not later than fourteen (14) days** from the
8 filing of this Order for Sanctions.


9 2. Plaintiff's counsel is further ordered to show cause
10 why he should not be sanctioned an additional **\$300.00** for his
11 failure to respond to legal deadlines and the court's orders, and
12 why plaintiff's case should not be dismissed for failure to
13 prosecute. Counsel shall file his response to this Order to Show
14 Cause on or before July 23, 2010.

15 3. The hearing currently set for July 9, 2010 for
16 defendant's Motion to Dismiss is VACATED and RESET for August 6,
17 2010 at 10:00 a.m. Plaintiff shall file and serve his opposition
18 brief or notice of non-opposition no later than July 23, 2010.
19 The defendant may file and serve a reply on or before July 30,
20 2010.

21 4. A hearing on the order to show cause, if necessary,
22 will follow the hearing on the motion.

23 IT IS SO ORDERED.
