**STIPULATION REGARDING WRIT OF
 GARNISHMENT; AND FINAL ORDER
 THEREON**

 20 Plaintiff United States and defendant Chabad of California (the Parties) hereby stipulate to the
 21 resolution of the United States' pending garnishment action as follows:

22 1. An amended judgment in the amount of \$713,090.00 was entered against Chabad of
 23 California (Chabad) on October 14, 2015. The Clerk of Court taxed costs against Chabad in the amount
 24 of \$17,302.99 on November 5, 2015. Combined, the amended judgment and cost bill total \$730,392.99.
 25 To date, the judgment and cost bill remain unpaid.

26 2. The United States sought, and the Clerk issued, a writ of garnishment on February 9,
 27 2016 against Chabad's accounts at garnishee Comerica Bank (Comerica). ECF No. 155.

1 **ORDER**

2 The Court, having reviewed the court files and the Parties' Stipulation Regarding Writ of
3 Garnishment (the Stipulation), and finding good cause therefrom, hereby approves the Stipulation.

4 ACCORDINGLY, the Court hereby ORDERS, ADJUDGES and DECREES as follows:

5 1. The United States' application for a final order of garnishment in the amount of \$1,267.00
6 is granted;

7 2. Comerica Bank shall deliver to the United States Department of Justice, within 20 days of
8 the filing of this Order, a cashier's check, money order or company draft in the sum of \$1,267.00 drawn
9 from defendant Chabad of California's business checking account numbers x-3769 and x-0486 and made
10 payable to the "United States Department of Justice" at the United States' Attorney's Office, Eastern
11 District of California (Attn: Tina Baca), 501 I Street, Suite 10-100, Sacramento, California 95814.

12 Comerica Bank shall state the docket number (Case No.: 2:10-cv-01056-MCE-EFB) on the payment
13 instrument and, if it desires a payment receipt, shall include a self-addressed, stamped envelope with the
14 payment;

15 3. Upon its payment of the \$1,267.00 to the United States, Comerica Bank shall release its
16 hold on Chabad of California's business checking account numbers x-3769 and x-0486; and

17 4. This is a final order of garnishment; upon payment and processing of the garnished amount
18 as ordered above, this writ shall terminate pursuant to 28 U.S.C. § 3205(c)(10)(B).

19 IT IS SO ORDERED.
