

20 WHEREAS, a Verified Complaint for Forfeiture *In Rem* has been
21 filed on May 21, 2010, in the United States District Court for
22 the Eastern District of California, alleging that the defendants
23 Approximately \$75,750.00 in U.S. Currency, Approximately
24 \$27,910.00 in U.S. Currency, and 2006 Bristers TW413 Trail Wagon
25 UTV, VIN: BDMUTXH1K7A09112A, (hereafter "defendant properties"),
26 are subject to forfeiture to the United States pursuant to 21
27 U.S.C. §§ 881(a)(4) and 881(a)(6) for one or more violations of
28 21 U.S.C. §§ 841 et seq.;

1 And, the Court being satisfied that, based on the Verified
2 Complaint for Forfeiture *In Rem* and the affidavit of Drug
3 Enforcement Administration Special Agent Brian Nehring, there is
4 probable cause to believe that the defendant properties so
5 described constitute properties that are subject to forfeiture
6 for such violation(s), and that grounds for the issuance of a
7 Warrant for Arrest of Articles *In Rem* exist, pursuant to Rule
8 G(3)(b)(i) of the Supplemental Rules for Admiralty or Maritime
9 Claims and Asset Forfeiture Actions;

10 IT IS HEREBY ORDERED that the Clerk for the United States
11 District Court, Eastern District of California, shall issue a
12 Warrant for Arrest of Articles *In Rem* for the defendant
13 properties.
