19	June 9, 2010, plaintiff filed a motion to compel defendants' representatives to provide him with a		
20	certified trust account statement. However, plaintiff also filed a notice of change of address		
21	indicating he has been released from custody. Accordingly, plaintiff is no longer a "prisoner" as		
22	defined by 28 U.S.C. § 1915(h), and is no longer required to provide the certified trust account		
23	statement. Plaintiff is, however, required to either submit the appropriate affidavit in support of a		
24	request to proceed in forma pauperis or to submit the appropriate filing fee.
