8 Examination of the above-entitled actions reveals that these
 9 actions are related within the meaning of Local Rule 123 (E.D. Cal.
 10 2005). Accordingly, the assignment of the matters to the same
 11 judge and magistrate judge is likely to affect a substantial
 12 savings of judicial effort and is also likely to be convenient for
 13 the parties.

14 The parties should be aware that relating the cases under

20 IT IS THEREFORE ORDERED that the actions denominated 2:10-CV-
 21 01248-FCD-KJM (PS) and 2:10-CV-1349 FCD-DAD (PS) be reassigned to
 22 Judge John A. Mendez and Magistrate Judge Edmund F. Brennan for all
 23 further proceedings, and any dates currently set in this reassigned
 24 case only are hereby VACATED. Henceforth, the caption on documents
 25 filed in the reassigned cases shall be shown as 2:10-CV-01248-JAM-
 26 EFB (PS) and 2:10-CV-01349 JAM-EFB (PS).

1 IT IS FURTHER ORDERED that the Clerk of the Court make
2 appropriate adjustment in the assignment of civil cases to
3 compensate for this reassignment.

4 IT IS SO ORDERED.
