Plaintiff, a state prisoner proceeding without counsel, has filed a civil rights action pursuant to 42 U.S.C. § 1983 together with a request for leave to proceed in forma pauperis pursuant to 28 U.S.C. § 1915. However, the certificate portion of the request which must be completed by plaintiff's institution of incarceration has not been filled out. Also, plaintiff has not filed a certified copy of his prison trust account statement for the six month period immediately preceding the filing of the complaint. See 28 U.S.C. § 1915(a)(2). Plaintiff will be provided the opportunity to submit a completed in forma pauperis application and a certified copy in support of his application.

7 month period immediately preceding the filing of the complaint.

8 2. The Clerk of the Court is directed to send plaintiff a new Application to  
9 Proceed In Forma Pauperis By a Prisoner; and

10 3. Plaintiff's failure to comply with this order may result in the dismissal of this  
11 action without prejudice.
