18 STIPULATION AND ORDER FOR  
 REMAND PURSUANT TO  
 19 SENTENCE FOUR OF 42 U.S.C.  
 § 405(g), AND REQUEST FOR  
 ENTRY OF JUDGMENT IN FAVOR  
 OF PLAINTIFF AND AGAINST  
 DEFENDANT

20 IT IS HEREBY STIPULATED, by and between the parties, through their  
 21 respective counsel of record, that this action be remanded to the Commissioner of Social  
 22 Security for further administrative action pursuant to section 205(g) of the Social  
 23 Security Act, as amended, 42 U.S.C. § 405(g), sentence four.

24 On remand, the Administrative Law Judge (ALJ) will reconsider the opinions of  
 25 Drs. Kalman and Wong, reassess the Plaintiff's residual functional capacity, and obtain,  
 26 if necessary, supplemental vocational expert testimony to assist in determining what jobs  
 27 exist in significant numbers for the claimant given her age, education, vocational factors  
 28 and residual functional capacity.

1 The parties further request that the Clerk of the Court be directed to enter a final  
2 judgment in favor of Plaintiff, and against Defendant, Commissioner of Social Security,  
3 reversing the final decision of the Commissioner.
