Scott Salyer, individually and as trustee of the Scott Salyer Revocable Trust; the Scott 1 Salyer Revocable Trust; SK PM Corp.; SK Foods, LLC; SKF Canning, LLC; Blackstone Ranch 2 Corporation; Monterey Peninsula Farms, LLC; Salyer Management Company, LLC; SK Farms 3 Services, LLC; SK Frozen Foods, LLC; SS Farms, LLC; SSC Farming, LLC; SSC Farms I, LLC; 4 SSC Farms II, LLC; SSC Farms III, LLC; SKF Aviation, LLC; CSSS, LP d/b/a Central Valley 5 Shippers; Gerard Rose as trustee of the Fred Salyer Irrevocable Trust; and the Fred Salyer 6 Irrevocable Trust (collectively, "Appellants") and Bradley D. Sharp, as Chapter 11 Trustee of SK 7 Foods, L.P. ("Appellee"), by and through their respective counsel, hereby stipulate (the 8 "Stipulation") and agree as follows: 9 1. On December 27, 2010, Appellee filed the Motion for Rehearing on December 10, 10 2010 Order and Judgment Reversing Bankruptcy Court's Order Denying a Stay (the "Motion for 11 Rehearing") in the above-captioned appeals. The Motion for Rehearing was set for hearing on 12 January 31, 2011 at 10:00 a.m. and the deadline to file an opposition to the Motion for Rehearing 13 was January 17, 2011. 14 2. On December 30, 2010, Appellants filed an opposition to the Motion for 15 Rehearing, asking the Court to delay the hearing until sometime at the end of March 2011 16 because of the illness of one of Appellants' attorneys and reserving the right of Appellants to file 17 a supplemental opposition to the Motion for Rehearing. 18 3. On January 14, 2011, the Court entered an order (the "Extension Order") 19 extending the deadline for Appellants to file an opposition to the Motion for Rehearing until 20 January 19, 2011 at 9:00 a.m. 21 4. On or around January 14, 2011, Appellants and Appellee agreed to participate in 22 mediation concerning, among other things, the Motion for Rehearing with Judge Michael 23 McManus in the next sixty (60) days (the "Mediation"). Because the Motion for Rehearing will 24 be negotiated as part of the Mediation, Appellants and Appellee also agreed to postpone the 25 hearing on the Motion for Rehearing to no earlier than March 31, 2011 and, as a result, extend the 26 deadline to file an opposition to the Motion for Rehearing to no earlier than March 17, 2011. 27 5. file their opposition should be determined under the Local Rules of the United Stated District Court for the Eastern District of California (the "Local Rules") based on the date of the hearing 2 set by the Court. 3

6. Appellants and Appellee believe that delaying the hearing on the Motion for 4 Rehearing and extending the deadline to file an opposition to the Motion for Rehearing will 5 enhance the parties' ability in the Mediation to agree to a consensual resolution of the issues 6 raised in the Motion for Rehearing, although the parties are unable to guarantee at this time that 7 they will be successful. 8

7. On January 21, 2011, the Court entered an order (the "Order") requesting that 9 counsel for the Appellants file a notice indicating why they did not file a timely supplemental 10 opposition to the Motion for Rehearing pursuant to the Extension Order. 11

8. In response to the Order, Appellants hereby apologize to the Court for the delay in 12 filing this Stipulation. Between January 14, 2011 and January 24, 2011, Appellants and Appellee 13 were in the process of negotiating the details of an interim settlement agreement to delay the 14 numerous open issues between Appellants and Appellee, including the Motion for Rehearing, 15 while the participate in the Mediation. As a result of such efforts, Appellants and 16 Appellee are hereby filing this Stipulation. 17

9. As a result of the forgoing, Appellants and Appellee hereby jointly request that the 18 Court enter an order continuing the hearing on the Motion for Rehearing to a date no earlier than 19 March 31, 2011, with the deadline for Appellants to file their opposition to the Motion for 20 Rehearing to be determined under the Local Rules, based on the date of the hearing set by the 21 Court. 22
