**STIPULATION AND [PROPOSED]
 ORDER TO CONTINUE DATE FOR
 SETTLEMENT CONFERENCE TO
 APRIL 21, 2011**

23 Defendant Metropolitan Life Insurance Company (“MetLife”) and plaintiff Candice
 24 Garcia (“plaintiff”) (collectively “Parties”), through their respective counsel of record herein,
 25 hereby STIPULATE and AGREE as follows:

26 On February 7, 2011, the Court filed the Pretrial Scheduling Order (ECF No. 12), setting
 27 a Settlement Conference before the Honorable Edmund F. Brennan on March 17, 2011 at 10:00
 28 a.m. Due to scheduling conflicts, MetLife is unable to have a representative present at the

1 Settlement Conference on March 17, 2011. MetLife is able to have a representative present for a
2 Settlement Conference on April 21, 2011, a date that MetLife understands is currently available
3 on the Court's calendar.

4 Accordingly, the Parties stipulate and respectfully request the Court continue the date of
5 the Settlement Conference from March 17, 2011 to April 21, 2011.

6 Currently, plaintiff's dispositive motion is due April 21, 2011; however, the Parties have
7 agreed to continue this date and will submit a separate Stipulation and [Proposed] Order to the
8 Court requesting a continuance of this date, as well as the dates for the Parties' responsive
9 briefing, to accommodate the continuance of the Settlement Conference.

10 NOW, THEREFORE, the Parties hereby stipulate and respectfully request that the Court
11 continue the Settlement Conference to April 21, 2011 at 10:00 a.m. in Courtroom 24.
