ORDER FOR PAYMENT

15 \_\_\_\_\_ / OF INMATE FILING FEE

16 To: The Director of the Nevada Department of Corrections, 5500 Snyder Avenue, Building 17,  
17 Carson City, Nevada 89701:

18 Plaintiff, a state prisoner proceeding pro se and in forma pauperis, is obligated to  
19 pay the statutory filing fee of \$350.00 for this action. Plaintiff has been assessed an initial partial  
20 filing fee of \$15.27 for this action pursuant to 28 U.S.C. § 1915(b)(1). Upon payment of that  
21 initial partial filing fee, plaintiff will be obligated to make monthly payments in the amount of  
22 twenty percent of the preceding month's income credited to plaintiff's trust account. The Nevada  
23 Department of Corrections is required to send to the Clerk of the Court the initial partial filing  
24 fee and thereafter payments from plaintiff's prison trust account each time the amount in the  
25 account exceeds \$10.00, until the statutory filing fee of \$350.00 is paid in full. 28 U.S.C.  
26 § 1915(b)(2).

1 Good cause appearing therefore, IT IS HEREBY ORDERED that:

2 1. The Director of the Nevada Department of Corrections or a designee shall  
3 collect from plaintiff's prison trust account an initial partial filing fee in the amount of \$15.27  
4 and shall forward the amount to the Clerk of the Court. Said payment shall be clearly identified  
5 by the name and number assigned to this action.

6 2. Thereafter, the Director of the Nevada Department of Corrections or a designee  
7 shall collect from plaintiff's prison trust account the \$334.73 balance of the filing fee by  
8 collecting monthly payments from plaintiff's prison trust account in an amount equal to twenty  
9 percent (20%) of the preceding month's income credited to the prisoner's trust account and  
10 forwarding payments to the Clerk of the Court each time the amount in the account exceeds  
11 \$10.00 in accordance with 28 U.S.C. § 1915(b)(2). The payments shall be clearly identified by  
12 the name and number assigned to this action.

13 3. The Clerk of the Court is directed to serve a copy of this order and a copy of  
14 plaintiff's signed in forma pauperis affidavit on Director, Nevada Department of Corrections,  
15 5500 Snyder Avenue, Building 17, Carson City, Nevada 89701.

16 4. The Clerk of the Court is directed to serve a copy of this order on the Financial  
17 Department of the court.
