ORDER SETTING SETTLEMENT
 NEGOTIATION SCHEDULE

Magistrate Judge: Hon. Gregory G. Hollows

21 On July 13, 2011, the undersigned presided over a settlement conference (“Conference”)
 22 between Plaintiff California Sportfishing Protection Alliance (“Plaintiff”) and Defendant William
 23 Callaway (“Defendant”) (collectively, the “Parties”).

24 As a result of the Conference, Defendant has agreed to provide Plaintiff documentation of
 25 his financial assets pursuant to the terms set forth in the Protective Order concurrently issued by
 26 the Court in tandem with the instant Order. Specifically, Defendant agreed to deliver to Plaintiff
 27 no later than two weeks from July 13, 2011, true and correct copies of his filed tax returns for the
 28 past three years (i.e., 2008, 2009 and 2010), including the “Schedule C” report included in his

1 filing of each of those tax returns. Additionally, Defendant agreed to deliver to Plaintiff no later
2 than two weeks from July 13, 2011, true and correct copies of asset statements reflecting the
3 current value of each of Defendant's assets (i.e., both real and personal property) valued in excess
4 of one thousand dollars.

5 Finally, during the Conference, the Parties agreed to participate in a second settlement
6 conference in August, 2011, at a date and time to be subsequently determined by the Court as a
7 date and time that is mutually convenient for both the Parties and the Court.

8 **ORDER**

9 Pursuant to agreement as expressed by the parties during their July 13, 2011 settlement
10 conference, and good cause appearing, it is ORDERED that Defendant William Callaway
11 ("Defendant") shall deliver to Plaintiff California Sportfishing Protection Alliance ("Plaintiff") no
12 later than two weeks from July 13, 2011, true and correct copies of his filed tax returns for the
13 past three years (i.e., 2008, 2009 and 2010), including the "Schedule C" report included in his
14 filing of each of those tax returns. Additionally, Defendant shall deliver to Plaintiff no later than
15 two weeks from July 13, 2011, true and correct copies of asset statements reflecting the current
16 value of each of Defendant's assets (i.e., both real and personal property) valued in excess of one
17 thousand dollars.

18 Finally, the Parties shall appear at a second settlement conference to be presided over by
19 the undersigned on August 2, 2011, at 9:00 a.m. in Courtroom No. 9.
