 21 respective attorneys, subject to the approval of the Court, that:

22 1. On August 20, 2010, this Court, by the Honorable Frank C. Damrell,
 23 Jr., issued a temporary injunction, pursuant to Petitioner’s Petition for Injunction Under
 24 Section 10(j) of the National Labor Relations Act, pending final administrative disposition of
 25 the matters involved pending before the National Labor Relations Board (the “Board”).
