 27 rules as follows:

1 1. The Complaint shall be unsealed and served upon the
2 defendants by the relator;

3 2. All other contents of the Court's file in this action shall
4 remain under seal and not be made public or served upon the defendant,
5 except for this Order and the Notice of Election to Decline
6 Intervention, which the relator shall also serve upon the defendants;

7 3. The seal shall be lifted as to all other matters occurring in
8 this action after the date of this Order;


9 4. The parties shall serve all pleadings and motions filed in
10 this action, including supporting memoranda, upon the United States,
11 as provided for in 31 U.S.C. § 3730(c)(3). The United States may
12 order any deposition transcripts and may seek to intervene in this
13 action, for good cause, at any time;

14 5. All orders of this Court shall be sent to the United States;
15 and

16 6. Should the relator or the defendants propose that this action
17 be dismissed, settled, or otherwise discontinued, the relator shall
18 provide the United States with notice and an opportunity to be heard
19 before the Court rules or grants its approval.
