- 2. Local Rule 171, Eastern District of California, provides that the Court shall designate by order the appropriate newspaper

- 3. The defendant real property is located in the city of North San Juan, in Nevada County, California;
 - 4. Plaintiff proposes that publication be made as follows:
 - a. One publication;
 - b. Thirty (30) consecutive days;

 - d. The publication is to include the following:
