Examination of the above-entitled actions reveals that 2 these actions are related within the meaning of Local Rule 3 123(a) because both cases involve the same parties and are based 4 on similar claims resulting from the same business relationship, 5 contract, and/or franchise agreement. Accordingly, the 6 assignment of the matters to the same judge is likely to effect 7 a substantial saving of judicial effort and is also likely to be 8 convenient for the parties. 9

The parties should be aware that relating the cases under Local Rule 123 merely has the result that both actions are assigned to the same judge; no consolidation of the actions is effected. Under the regular practice of this court, related cases are generally assigned to the judge and magistrate to whom the first filed action was assigned.

IT IS THEREFORE ORDERED that the actions denominated 16 Century 21 Real Estate LLC v. All Professional Realty, Inc. et 17 al., Civ. No. 2:10-2751 WBS GGH and Wright et al. v. Century 21 18 Real Estate LLC et al., Civ. No. 2:10-2846 FCD GGH, be, and the 19 same hereby are, deemed related and the case denominated Wright 20 et al. v. Century 21 Real Estate LLC et al., Civ. No. 2:10-2846 21 FCD GGH, shall be reassigned to the Honorable WILLIAM B. SHUBB 22 and remain with Magistrate Judge Gregory G. Hollows for all 23 further proceedings. Any dates currently set in the reassigned 24 case only are hereby VACATED. Henceforth, the caption on 25 documents filed in the reassigned case shall be shown as Wright 26 et al. v. Century 21 Real Estate LLC et al., Civ. No. 2:10-2846 27 WBS GGH. 28
