STIPULATION AND ORDER FOR  
 REMAND PURSUANT TO  
 SENTENCE FOUR OF 42 U.S.C.  
 § 405(g), AND REQUEST FOR  
 ENTRY OF JUDGMENT IN FAVOR  
 OF PLAINTIFF AND AGAINST  
 DEFENDANT

 20 IT IS HEREBY STIPULATED, by and between the parties, through their  
 21 respective counsel of record, that this action be remanded to the Commissioner of Social  
 22 Security for further administrative action pursuant to section 205(g) of the Social  
 23 Security Act, as amended, 42 U.S.C. § 405(g), sentence four.

24 On remand, the Administrative Law Judge (ALJ) will further evaluate Plaintiff's  
 25 residual functional capacity with additional consideration of the medical source opinion  
 26 evidence. The ALJ will also obtain vocational input, and give further consideration to  
 27 steps four and five of the sequential evaluation process. The Appeals Council and/or  
 28 ALJ may take any additional action deemed warranted to issue a new decision.

1 The parties further request that the Clerk of the Court be directed to enter a final  
2 judgment in favor of Plaintiff, and against Defendant, Commissioner of Social Security,  
3 reversing the final decision of the Commissioner.
