MOTION TO SUBSTITUTE DOE

18 The undersigned parties, through counsel, STIPULATE and AGREE and jointly request that:

- 20 1. On August 26, 2011, this Court ordered that Plaintiff conduct discovery forthwith in order to
21 discover the identity of the Doe Defendants. Plaintiff was given a deadline of 90 days to file a
22 motion to amend accordingly.
 - 23 2. On September 6, 2011, Plaintiff propounded Special Interrogatories and Demands for
24 Production of Documents in order to ascertain the identities of the Doe Defendants.
 - 25 3. Plaintiff has granted Defendant numerous discovery extensions because personnel from the City
26 of Tracy's Police Department have been on extended leave, precluding Defendant from
27 responding to the outstanding discovery.
 - 28 4. Accordingly, the parties agree that Plaintiff's deadline to file a motion substitute the Doe

1 Defendants in this case shall be extended an additional 45 days from the original deadline date.


