1 **RECITALS**

2 On June 7, 2011, the Court issued its Status (Pretrial Scheduling) Order. (CM/ECF Doc.  
3 No. 55.) In that Order, the Court set the claim construction hearing in this matter for July 23,  
4 2012, with the parties to file their Joint Claim Construction Statement by May 11, 2012.

5 Recent discussions between Plaintiff ICONFIND INC. and Defendant GOOGLE INC.  
6 have elicited a mutually-held desire to install additional deadlines relating to the claim  
7 construction process, all of which are consistent with the above-mentioned deadlines already  
8 imposed by the Court. The additional deadlines agreed to by the parties are set forth below.

9 **STIPULATION**

10 Given the above, the parties HEREBY STIPULATE, subject to the Court's approval, that  
11 the below claim construction-related deadlines shall operate in this matter. (Note that the dates  
12 already ordered by the Court are italicized and bolded, while the newly-added dates are in regular  
13 text.)

14 1. February 13, 2012: Last day for each party to serve on the other its Proposed  
15 Terms for Construction.

16 2. March 28, 2012: Last day for the parties to simultaneously exchange their  
17 Proposed Claim Constructions and Extrinsic Evidence. (Simultaneous exchange to occur at a  
18 specific time of the parties' choosing.)

19 3. ***May 11, 2012***: Last day for the parties to file their Joint Claim Construction and  
20 Prehearing Statement.

21 4. May 15, 2012: Last day for each party to file its opening claim construction brief  
22 and supporting evidence.

23 5. June 12, 2012: Last day for each party to serve and file its responsive claim  
24 construction brief and supporting evidence.

25 6. ***June 25, 2012 at 9:00 a.m.***: In-court tutorial described at Paragraph 6 of the  
26 Court's June 7, 2011 Order.

27 7. ***July 23, 2012 at 9:00 a.m.***: Claim construction hearing.

28 All specifications set forth in the Court's June 7, 2011 Order remain fully operative.
