21 **JOINT STATUS REPORT AND STIPULATION**

22 Plaintiff Sharon Newton and Defendant Clearwire Corporation, by and through their
 23 counsel, provide this joint status report and stipulate to the following and request that the Court
 24 stay this matter until March 16, 2012, so the parties can continue their settlement discussions,
 25 which remain ongoing following their formal mediation. The parties jointly request that the Court
 26 enter the following Order approving this Stipulation.

27 In support of this request, the parties represent the following to the Court:

1 1. On December 12, 2011, the Court entered an order [Dkt. 39] approving the parties'
2 stipulation and (i) staying the case until January 12, 2012, to allow the parties to mediate their
3 dispute, as well as other matters involving Clearwire; (ii) vacating the hearing on Clearwire's
4 Motion to Compel Arbitration [Dkt. 18]; and (iii) directing the parties to submit a joint status
5 report at the expiration of the stay.

6 2. The parties engaged in formal mediation on January 4 and 5, 2012, and their
7 settlement discussions from that mediation remain ongoing.

8 3. On January 13, 2012, the parties requested [Dkt. 40] and the Court granted
9 [Dkt. 41] an extension of the stay to allow settlement discussions to continue.

10 4. To allow the parties to continue their settlement discussions and focus their efforts
11 on resolving this dispute amicably, they jointly ask the Court to stay the case until February 28,
12 2012.
