25 In reviewing his file, Plaintiff's counsel discovered his staff had made a clerical error in
 26 preparing the Complaint filed in this matter, specifically, paragraph 4 which lists the barriers to
 27 access which Plaintiff encountered at the facility which is the subject of this action has
 28 incorrect information in it. Plaintiff's counsel's office staff inadvertently inserted a list of access
 barriers from a report prepared by the access consultant for a different facility.

Plaintiff desires to file a First Amended Complaint to correct Paragraph 4 inserting the

 subject of this action, a copy of which is attached hereto as Exhibit "A."
