17	Federal Tort Claims Act ("FTCA") claim and First Amendment and Eighth Amendment claims	
18	under Bivens v. Six Unknown Named Agents of Federal Bureau of Narcotics, 403 U.S. 388	
19	(1971). The matter was referred to a United States Magistrate Judge pursuant to 28 U.S.C. §	
20	636(b)(1)(B) and Local Rule 302.	
21	On September 4, 2014, the Magistrate Judge filed an Order and Findings and	
22	Recommendations; the findings and recommendations contained therein concern Defendants	
23	United States of America, Jay Salinas, Ryan Binford, and Joe Fieber's motion to dismiss, (ECF	
24	No. 44). The findings and recommendations were served on all parties and contained notice that	
25	any objections to the findings and recommendations were to be filed within fourteen days. No	
26	objections to the findings and recommendations were filed.	
27	The court has reviewed t	he file and finds the referenced findings and
	.l	

recommendations to be supported by the record and by the Magistrate Judge's analysis.

1	Accordingly, IT IS HEREBY ORDERED that:	
2	1. The findings and recommendations filed September 4, 2014, are adopted in	
3	full;	
4	2. Defendants' motion to dismiss, (ECF No. 44), is granted;	
5	3. Plaintiff's FTCA and First Amendment claims are dismissed with	
6	prejudice;	
7	4. Plaintiff is granted thirty (30) days from the date on which this order is	
8	filed to file a Third Amended Complaint addressing the deficiencies referenced in the September	
9	4, 2014 findings and recommendations on the Eighth Amendment claim alleged against	
10	Defendants Salinas, Binford, and Fieber; and	
11	5. Plaintiff is warned that this action may be dismissed with prejudice under	
12	Federal Rule of Civil Procedure 41(b) if Plaintiff fails to timely file a Third Amended Complaint.
