21 Whereas, the Parties have engaged in two days of mediation with Judge Ronald Sabraw
(Ret.) as mediator;

22 Whereas the Court has ordered that Plaintiffs' Motion for Class Certification be filed on or
23 before August 15, 2012 and noticed for hearing on September 19, 2012 at 9:30 a.m.;

1 Whereas the Parties request that the schedule for Plaintiffs' Motion for Class Certification
2 be extended to allow discovery delayed due to settlement discussions and the mediations;

3 Accordingly, the Parties agree as follows:

4 The schedule for the filing of Plaintiffs' Motion for Class Certification is extended by
5 approximately one and a half months so that the Motion now shall be filed on or before October 5,
6 2012;

9 continuance of the hearing date from July 11, 2012 to September 10, 2012, for Plaintiff's Motion


