DISCOVERY

1 MOTION HEARING SCHEDULE

2 The parties state in the JSR that they anticipate filing
3 cross-motions for summary judgment and propose a briefing schedule for
4 the referenced motions. Id. at 3:4-5. The parties' proposed briefing
5 schedule is adopted, as modified, as follows:

6 Plaintiff's Motion for Summary Judgment shall be filed no
7 later than January 14, 2013;

8 Defendants' Opposition and Cross-Motion for Summary Judgment
9 shall be filed no later than February 4, 2013;

10 Plaintiff's Reply and Opposition shall be filed no later than
11 February 25, 2013;

12 Defendants' Reply shall be filed no later than March 18, 2013;


14 The hearing on the cross-motions for summary judgment shall be
15 noticed for April 8, 2013, at 9:00 a.m.

16 FURTHER STATUS CONFERENCE

17 In the event the referenced cross-motions for summary judgment
18 do not dispose of the case in its entirety, a further status conference
19 is scheduled to commence at 9:00 a.m. on June 24, 2013. A further joint
20 status report shall be filed fourteen (14) days before the status
21 conference, in which the parties shall address all pertinent subjects
22 set forth in Local Rule 240(a).
