15 This is an immigration case in which plaintiffs challenge the revocation of visa petitions filed
 16 by plaintiff Audrey Casillas by U.S. Citizenship and Immigration Services' (CIS) and seek an
 17 order of declaratory relief that the visa petitions be approved. The parties previously stipulated to
 18 hold the matter in abeyance pending an appeal to the Board of Immigration Appeals. As of the
 19 time of this filing, the matter remains pending at the Board of Immigration Appeals.

20 Because of the likelihood that adjudication by the Board of Immigration Appeals will render
 21 this action moot, the parties request that the case be held in abeyance until December 17, 2012,
 22 and that all case deadlines be extended to sometime after that date.
