Plaintiff has requested leave to proceed without the prepayment of fees and costs, also referred to as proceeding in forma pauperis, pursuant to 28 U.S.C. § 1915. Plaintiff has submitted the required affidavit, which demonstrates that plaintiff is unable to prepay fees and costs or give security for them. Accordingly, the request to proceed in forma pauperis is granted. See 28 U.S.C. § 1915(a).

For the foregoing reasons, IT IS HEREBY ORDERED that:


1. Plaintiff’s request to proceed in forma pauperis (Dkt. No. 4) is granted.
2. The Clerk of the Court is directed to serve the undersigned’s scheduling order in Social Security cases.
3. The Clerk of the Court is further directed to serve a copy of this order on the United States Marshal.

1 4. Within fourteen days from the date of this order, plaintiff shall submit to
2 the United States Marshal an original and five copies of the completed summons, five copies of
3 the complaint, five copies of the scheduling order and a completed USM-285 form, *and shall file*
4 *a statement with the court that such documents have been submitted to the United States*
5 *Marshal.*

6 5. The United States Marshal is directed to serve all process without
7 prepayment of costs not later than sixty days from the date of this order. Service of process shall
8 be completed by delivering a copy of the summons, complaint, and scheduling order to the
9 United States Attorney for the Eastern District of California, and by sending two copies of the
10 summons, complaint, and scheduling order by registered or certified mail to the Attorney General
11 of the United States at Washington, D.C. See Fed. R. Civ. P. 4(i)(1)(A) & (B). The Marshal
12 shall also send a copy of the summons, complaint, and scheduling order by registered or certified
13 mail to the Commissioner of Social Security, c/o Office of General Counsel, 6401 Security
14 Blvd., Room 611, Altmeyer Bldg., Baltimore, MD 21235. See Fed. R. Civ. P. 4(i)(2). *The*
15 *United States Marshal shall thereafter file a statement with the court that such documents have*
16 *been served.*
