1 The actions involve many of the same defendants and are based on 2 the same or similar claims, the same property transaction or event, similar questions of fact and the same questions of law, 3 and would therefore entail a substantial duplication of labor if 4 heard by different judges. Accordingly, the assignment of the 5 matters to the same judge is likely to effect a substantial 6 savings of judicial effort and is also likely to be convenient 7 8 for the parties.

9 The parties should be aware that relating the cases under 10 Local Rule 123 merely has the result that both actions are 11 assigned to the same judge; no consolidation of the action is 12 effected. Under the regular practice of this court, related 13 cases are generally assigned to the district judge and magistrate 14 judge to whom the first filed action was assigned.

15 IT IS THEREFORE ORDERED that the action denominated 2:11-cv-16 02171-JAM-CKD, Wells Fargo Bank, N.A. v. Sam Louis Latino is 17 reassigned to Judge Morrison C. England, Jr. and Magistrate Judge 18 Dale A. Drozd for all further proceedings, and any dates currently set in this reassigned case only is hereby VACATED. 19 20 The Clerk of the Court is to issue an Order Requiring Joint 21 Status Report. Henceforth, the caption on documents filed in the 22 reassigned case shall be shown as 2:11-cv-02171-MCE-DAD.
