Plaintiff states in his Status Report filed October 24, 2011: "Plaintiff and Defendants are currently in the process of finalizing a settlement agreement and a notice of settlement has been filed." (ECF No. 6.) However, a notice of settlement has not been filed in this action. But since Plaintiff represents that this action has settled, a document disposing of this action shall be filed no later than November 13, 2011. See L.R. 16-160(b) (stating a date for filing documents

1 disposing of the action "shall not be more than twenty (20) calendar  
2 days from the date of [when the settlement notification was received]".  
3 Failure to respond by this deadline may be construed as consent to  
4 dismissal of this action without prejudice, and a dismissal order could  
5 be filed. See L.R. 16-160(b) ("A failure to file dispositional papers  
6 on the date prescribed by the Court may be grounds for sanctions.").  
7 Further, the Status (Pretrial Scheduling) Conference scheduled for  
8 hearing on November 7, 2011 is continued to November 28, 2011 at 9:00  
9 a.m. A further joint status report shall be filed no later than fourteen  
10 (14) days prior.
