1 **STIPULATION**

2 Plaintiffs SHEILA GOODEN and MICHELLE HALL, and Defendant SUNTRUST  
3 MORTGAGE, INC., by and through their undersigned counsel, hereby stipulate as follows:

4 WHEREAS by Order dated April 4, 2013 (Docket No. 54), the Court set a deadline of  
5 December 18, 2013, for the Parties' exchange of Expert Witness Disclosures, and set a deadline  
6 of January 17, 2014, for the Parties' exchange of Supplemental/Rebuttal Expert Disclosures.

7 WHEREAS on November 15, 2013, the Court heard argument on Plaintiffs' Motion for  
8 Class Certification.

9 WHEREAS the Court took Plaintiffs' Motion for Class Certification under submission.

10 WHEREAS the Court issued an Order Denying Plaintiffs' Motion for Class Certification
