20 The County of San Bernardino and Relators Brent Stanley and Patrick
21 McKillop filed a Joint Stipulation of Dismissal of All Claims Asserted on Behalf of
22 the County of San Bernardino, pursuant to Fed. R. Civ. P. 41(a)(1)(i), the False
23 Claims Act, 31 U.S.C. § 3730(b)(1), and the California False Claims Act, Cal. Gov.
24 Code § 12652(c). Upon due consideration of the Stipulation and the papers on file in
25 this action,

26 **IT IS ORDERED** that,


27 Consistent with the terms of the December 17, 2014 Settlement Agreement
28 among the County of San Bernardino, Relators Brent Stanley and Patrick McKillop,

1 Iron Mountain Incorporated, and Iron Mountain Information Management, LLC, all
2 civil monetary claims asserted on behalf of the County of San Bernardino against
3 Iron Mountain Incorporated and Iron Mountain Information Management, LLC shall
4 be dismissed with prejudice.

5 The County of San Bernardino and Defendants shall each bear their own costs,
6 fees and expenses with respect to the claims asserted in this action on behalf of the
7 County of San Bernardino. The rights of Relators and/or their counsel to seek
8 recovery of reasonable expenses, fees and costs, including attorney's fees and costs
9 related to the Civil Action, are governed by the False Claims Act, 31 U.S.C. §§ 3729
10 *et seq.*, and the California False Claims Act, Cal. Gov't Code, §§ 12650, *et seq.* The
11 Court shall retain jurisdiction over this matter to resolve any dispute that may arise
12 relating to such claims.
