STIPULATION AND ORDER FOR
 REMAND PURSUANT TO SENTENCE
 FOUR OF 42 U.S.C. § 405(g), AND
 REQUEST FOR ENTRY OF JUDGMENT IN
 FAVOR OF PLAINTIFF AND AGAINST
 DEFENDANT

19 IT IS HEREBY STIPULATED, by and between the parties, through their respective counsel of
 20 record, that this action be remanded to the Commissioner of Social Security for further administrative
 21 action pursuant to section 205(g) of the Social Security Act, as amended, 42 U.S.C. § 405(g), sentence
 22 four.

23 On remand, the Administrative Law Judge (ALJ) will: (1) reassess the Plaintiff’s residual
 24 functional capacity; (2) obtain vocational expert testimony in order to evaluate the Plaintiff’s ability to
 25 perform her past relevant work or assess the availability of other work the Plaintiff could perform based
 26 on the assessed RFC; and (3) consider any new evidence submitted.

27 The parties further request that the Clerk of the Court be directed to enter a final judgment in
 28 favor of Plaintiff, and against Defendant, Commissioner of Social Security.
