Engineers employees Nancy Haley, Matthew Rabbe and Matthew Kelley<sup>1</sup> pursuant to Fed. R. Civ. P. 12(b)(6), but gave Shasta County twenty days from the date of the Court's Order to file an amended complaint, if it could do so consistent with the Court's Order. *See* Docket No. 33. Shasta County has not filed an amended complaint within twenty days of the Court's August 6, 2012 Order. Accordingly, the Court dismisses Shasta County's claims against the United States, Nancy Haley, Matthew Rabbe, and Matthew Kelley with prejudice.
