The May 30, 2012 Order Setting Status (Pretrial Scheduling) Conference scheduled a status conference in this case on October 1, 2012, and required the parties to file a joint status report no later than fourteen (14) days prior to the scheduling conference. The May 30, 2012 Order further required that a status report be filed regardless of whether a joint report could be procured. No status report was filed as ordered.


Therefore, Plaintiff is Ordered to Show Cause ("OSC") in a writing to be filed no later than October 1, 2012, why sanctions should not be imposed against it and/or its counsel under Rule 16(f) of the Federal Rules of Civil Procedure for failure to file a timely status report. The written response shall also state whether Plaintiff or its

1 counsel is at fault, and whether a hearing is requested on the OSC.¹ If
2 a hearing is requested, it will be held on October 15, 2012, at 9:00
3 a.m., just prior to the status conference, which is rescheduled to that
4 date and time. A status report shall be filed no later than fourteen
5 (14) days prior to the status conference.
