5	(	others. Correctional staff, however, may keep inmate Crossley under visual
6	5	surveillance during the conversation.
7	4. ]	Failure to comply with this order may result in an order requiring the Warden of
8		SVSP, or others responsible for the failure to comply, to appear before the court to
9	5	show cause why sanctions should not be imposed against them.
