STIPULATION AND ORDER RE SUBMISSION OF
SUPPORTING DOCUMENTATION FOR EXPERT

1 IT IS HEREBY STIPULATED and agreed by and between the UNITED STATES,
2 LENNAR MARE ISLAND, LLC (“LMI”), CH2M HILL CONSTRUCTORS, INC. (“CCI”),
3 and STEADFAST INSURANCE COMPANY (“STEADFAST”), and subject to approval by
4 the Court, as follows:

5 1. The parties are currently scheduled to exchange and file expert written reports
6 under Fed. R. Civ. Proc. 26(a)(2)(B) on May 3, 2017.

7 2. The parties expect some of those reports, the supporting documentation for
8 those reports, or both, to be extremely voluminous. The parties are concerned that documents
9 of this magnitude will be rejected by the Court’s electronic filing system. In addition, some of
10 the documents are Excel spreadsheets and it will be difficult to format those documents into
11 usable PDF versions that may be uploaded to the Court’s system.

12 3. Accordingly, the parties have agreed, subject to approval by the Court pursuant
13 to the attached [Proposed] Order, to file only the expert written reports and to electronically
14 submit to the Court and serve on the other parties any supporting documentation for those
15 reports. The parties propose using USB “thumb” drives but will use any other method
16 requested by the Court.
