18	withdraw as attorney of record. (ECF No. 12	27.) The motion was set for hearing before the
19	undersigned on March 3, 2016, at 10:00 a.m.	, in Courtroom 25.
20	At the hearing on March 3, 2016, Reb	becca Ihejirika appeared on her own behalf, Drew
21	Larson appeared on behalf of defendant Khai	ra, and plaintiff Milton Sykes appeared by phone.
22	Mr. Reager, counsel for defendants Athannas	sious, Bick, and Weiland, failed to appear.
23	During the hearing, the parties discus	sed the pre-trial motion deadline, which is currently
24	set for July 1, 2016. Mr. Reager is advised th	hat the court is considering advancing the pre-trial
25	motion deadline in light of the time constrain	ts facing plaintiff's pro bono counsel, who has
26	agreed to remain in the case through the reso	lution of any motions for summary judgment. Mr.
27	Larson has indicated that defendant Khaira is	s prepared to file a motion for summary judgment
28	within the next thirty to sixty days. However	r, due to Mr. Reager's failure to appear at the

1	hearing, the court remains uninformed as to whether defendants Athannasious, Bick, and Weiland
2	will be able to file their summary judgment motion within this time frame, assuming that they
3	intend to file such a motion.

4	Accordingly, IT IS HEREBY ORDERED that:	
5	1. Mr. Reager, shall within seven (7) days after the filing date of this order, show cause in	
6	writing why he failed to appear at the March 3, 2016 hearing and why this court should	
7	not impose monetary sanctions on him for his failure to appear.	
8	2. Mr. Reager is further ordered, within the above time frame, to inform the court as to	
9	whether defendants Athannasious, Bick, and Weiland anticipate filing a motion for	
10	summary judgment in this case, and if so, to show cause why this motion could not be	
11	filed within the next sixty days.
