25 On June 28, 2016, based on the parties’ stipulation, the court entered an order extending
26 the time for filing of Plaintiff’s opposition to Defendants’ motions for summary judgment and
27 Defendants’ reply.

28 On May 20, 2016, the court appointed Rebecca A. Weinstein-Hamilton as co-counsel to
29 represent Plaintiff for the limited purpose of opposing Defendants’ motions for summary
30 judgment.

31 Due to the length of time it took to obtain Plaintiff’s expert evaluation, it has become
32 necessary to get an extension of time up to November 30, 2016, to respond to Defendants’
33 motion for summary judgment.

1 The parties agree that the time for Plaintiff to file his opposition to Defendants' motion
2 for summary judgment should be extended to November 30, 2016. The parties agree that
3 Defendants' reply shall be due within forty-five (45) days after filing of Plaintiff's opposition
4 to the motions for summary judgment.

5 The parties stipulate that an extension of time up to November 30, 2016, for Plaintiff to
6 file his oppositions to the motions for summary judgment will not significantly impact the
7 progress of this case or prejudice the Defendants. This request is not brought for any improper
8 purpose.

9 Plaintiff, by and through his attorney of record –Rebecca E. Ihejirika; and Defendants -
10 Dr. Athannasious, Dr. Weiland and Dr. Bick by and through their attorney - Deputy Attorney
11 General – Kevin W. Reager, together with Defendant – Dr. Khaira by and through his attorney
12 – Theodore D. Poppinga, hereby stipulate that the Court grant the said parties an extension of
13 the deadline by which Plaintiff shall file his oppositions to the motions for summary judgment
14 and the Defendants' shall file their reply.

15 WHEREFORE, Plaintiff, by and through his attorney of record –Rebecca E. Ihejirika, and
16 Defendants - Dr. Athannasious, Dr. Weiland and Dr. Bick by and through their attorney -
17 Deputy Attorney General – Kevin W. Reager, together with Defendant – Dr. Khaira by and
18 through his attorney – Theodore D. Poppinga hereby request as follows:

19 (1) The deadline for Plaintiff to file his Oppositions to the Motions for Summary Judgment
20 is extended up to and including, November 30, 2016.

21 (2) The Defendants' reply shall be due within forty-five (45) days after filing of Plaintiff's
22 Oppositions to the Motions for Summary Judgment.


