27	imposition of monetary sanctions. See Local Rule 110.

1	3. Mr. Wilfred T. Fong, Deputy Attorney General, is requested to inform the court, within	
2	fourteen (14) days after the filing date of this order, whether the California Attorney General's	
3	Office will waive service of process for defendant Dr. Bick, as suggested in defense counsel's	
4	statement filed October 15, 2013, and, if so, to file such waiver.	
5	4. Should the Attorney General's Office waive service of process for Dr. Bick, defense	
6	counsel shall, within thirty (30) days thereafter, file and serve a pleading responsive to the	
7	complaint.	
8	5. The Clerk of Court shall, in addition to serving this order via the court's Case	
9	Management/Electronic Case Files (CM/ECF) system, mail the following documents to Mr.	
10	Fong: (1) a copy of this order; (2) a Waiver of Service of Summons, customized for defendant	
11	Dr. Bick; and (3) a copy of the endorsed complaint filed October 15, 2012 (ECF No. 1). The
