I am the mother of plaintiff, Emma Angell-Murray. She is currently 3 years old and we live together at 3876 Wellington Place, Shasta Lake, CA 14 96019 in Shasta County. 15 16 2. I am competent to protect the rights of my daughter as a plaintiff in this lawsuit. 3. I have no interest adverse to that of my daughter. I am not associated in business with 17 18 any of the adverse parties or their counsel. 19 Subject to the approval fo the court, I have retained counsel to represent my daughter and 4. 20 me in this case. My daughter needs me to be her guardian ad litem in order to pursue 21 certain causes of action on her behalf. Her causes of action arise out of the following 22 facts: Emma was born with a heart impairment and has since failed to thrive with height and weight below the 3rd percentile. Because of her impairments and on the advise of 23 24 her doctors, I applied for Social Security/SSI disability benefits for Emma. Social 25 Security has denied her application for benefits stating that she is not disabled. I have 26 appealed the denial through all the administrative stages and have retained counsel to 27 pursue her claim in federal court.
