1 PURSUANT TO THE STIPULATION OF THE PARTIES AND FOR GOOD CAUSE
2 APPEARING, THE COURT HEREBY ORDERS:

3 1. That the fact and expert discovery deadline in this matter be extended to March 11,
4 2015;

5 2. That Defendants will complete production of documents/data in their custody,
6 control and/or possession responsive to Plaintiffs' RFP Nos. 1-12 (Doc. 58) by January 14, 2015;

7 3. That the hearing on Plaintiffs' Motion to Compel now scheduled to be heard on
8 January 7, 2015 be continued to January 21, 2015;

9 4. The parties will request that the January 21, 2015 hearing will be taken off calendar
10 should Defendants complete production of documents noted herein; and

11 5. The parties request that the dispositive motion deadline be extended from April 9,
12 2015 to May 7, 2015.

13 6. The parties are admonished that further requests to modify the scheduling order
14 will be looked upon with disfavor.
