1 Defendants have moved the Court for an order permitting defendants to file a memorandum 2 of law up to fifty (50) pages in length. 3 In this consolidated proceeding, each of the three plaintiffs filed a motion for summary 4 judgment on June 24, as provided in the Court's stipulated scheduling Order (ECF 95). 5 Defendants' consolidated memorandum in opposition to plaintiffs' motions and in support of 6 defendants' own motion for summary judgment is due July 24. This Court's Case Management 7 Procedures establish "a page limit on dispositive motions of twenty (20) pages on all initial 8 moving papers, twenty (20) pages on oppositions, and ten (10) pages for replies," and further 9 provide that "[a]ny party wishing to file lengthier documents must first seek relief from said page 10 limitation requirement from the Court." 11 For the reasons set forth in defendants' motion, that motion is GRANTED, and the Court 12 grants defendants leave to file a consolidated memorandum, in opposition to plaintiffs' three 13 motions for summary judgment and in support of defendants' cross-motion for summary judgment, 14 not to exceed fifty (50) pages. 15 Dated: July 7, 2014 16
